Mission Antyodaya project is an accountability and convergence framework for transforming lives and livelihoods on measurable outcomes aiming to bring optimum use and management of resources allocated by 27 Ministries Department of the Government of India under various programmes for the development of rural areas. It is envisaged as state-led initiative with Gram Panchayats as focal points of convergence efforts. The process re-engineering objective for this project was to minimize the process complexity, cost and service delivery time along with Ease of doing survey, multilingual MIS and App, conduct survey in fast pace, real time data upload, less requirement of re-verification of data, Data Accuracy, better use of collected data by related stakeholders. Other primary objective was use of Improved Questionnaire (more accurate and effective, dynamic questions for both infrastructure as well as access to service after discussion with all stakeholders) to take

inputs for Multidimensional approach under. The objective was to Use the Latest Technology for data handling, data security, data accuracy, Increased transparency levels with Improved citizens focus and experience with low admin cost.

For Community Resource persons (CRPs) doing MA survey at GP level have reduced their survey conduct time by more than 40%. The dynamic improved questionnaires are easy to fill and has been designed in a way that conduct of survey is faster, Data captured using Geotagging, Geofencing, pictures captured as proof using mobile app, maker and checker facility, dropdown menus in most of the questions, multilayer workflow, Data Leakage, real time data sharing with stakeholders after final submission have great impact in saving administration cost and time of survey all over India.

It has impacted in Evidence based Identification through Direct Benefit Transfer, Social Audit, integrated MIS, Convergence and in monitoring the progress periodically. After process reengineering in MA the reverification of data captured at ground has reduced at around 20 %. For stakeholders and beneficiaries, project has impacted in measuring performance of GPs and wellbeing of households in terms of infrastructure and access of services. All 27 ministries now planning at cluster level more effectively. This has also help in the Gram Panchayat Development

Plan (GPDP), Pooling resources, working with set timelines and KPIs, Supporting institutions and professionals and Coordination structures. This has helped in minimized data re-verification, and easy audit.
